1. In the absence of instructions to the contrary, all items shipped in one day must be consolidated.
2. We may debit your company for unauthorized deviations incurring excessive freight charges.
3. Indicate purchase order number on bill of lading.
4. Premium transportation must be authorized. Please obtain an authorization number from Powers and Sons and include this number on your air bill or bill of lading.
5. Do not ship prepay-and-add. For parcel ground shipments (i.e. UPS or FedEx)

We prefer UPS Ground - Collect. Account # 496619. For anything other than UPS contact us.

Method of Shipment:

Shipments weighing 115 lbs. or less UPS GROUND – Collect 496619 Parcel ground service

All other shipments Please register at CT Logistics and submit.

LTL shipments online to CT Logistics

For P&S Truckload, FTL, or expedite shipment contact P&S Production, highlighted above.
